Notts Local Community Fund - Small Revenue Grants and Capital Funding Applications for revenue funding are invited from community organisations that have developed effective activities in response to a local need / gap analysis.

Organisations can apply at any time. The maximum award for revenue projects will be £5,000.

Homes for Ukraine Fund

An allocation of £300,000 has been approved by Nottinghamshire County Council to support proposals up to a maximum of £5,000 per application.
