Speaker Biographies

Lucie Andrews Head of Innovation and Growth, East Midlands County Combined Authority (EMCCA)

Appointed in September 2024, Lucie is bringing 25+ years of experience in skills and strategy development to this new role in EMCCA. Lucie will lead on all matters of economic policy from the original and any further devolution deals relating to business support, trade and investment, and innovation.

Lucie will work across the institution and with partners managing relationships with key partners to agree and deliver a new and fit for purpose model for business support across the EMCCA area, building on the existing work by LEP and UKSPF-funded programmes and in anticipation of future policy change on delivery models.

As substantial employing sector working across our region, with many VCSE organisations trading and in scope for future business support, whilst also being central to previous programmes focusing on inclusive growth, Lucie will explore what this may this mean for the VCSE sector as EMCCA evolves.

Marc has worked in VCS grants management for more than 27 years, with a couple of side steps in between. Spending 15 years working on Environment Grants funding programmes, working with a range of VCS groups, Marc joined TNLCF in February 2018 when it moved to its Regional way of working approach.

Marc's role of Funding Manager comes with the responsibility of oversight of Nottinghamshire and Derbyshire, supported by a team of four Funding Officers. Marc will share the latest developments and position on the new TNL strategy and what it means for the VCSE sector in the East Midlands.

Clifford Stevenson, Professor of Social Psychology & Director of Psychological Research, Nottingham Trent University

Clifford is a Professor of Social Psychology at NTU and a member of the Groups, Identities and Health research group. His research explores how social groups help reduce loneliness and improve wellbeing among their members. He recently led an AHRC investigation of placed-based Social Prescribing in Mid-Nottinghamshire.

Clifford has been an active partner in the Tackling Loneliness Collaborative and will outline the significance of place in determining health outcomes and what research tells us makes the biggest difference when tackling loneliness.
