

#### CO alarm exemptions



#### Care home incident

It's thankfully very rare that CO makes the main headline news on the BBC Six O'Clock News, but that is unfortunately what happened on 23rd October last year.

Three residents at a care home in Swanage, Dorset were found dead, four people were taken to hospital and CO poisoning was suspected as the cause. Although not yet confirmed as the investigation is continuing, we have had new interest in our Think CO training about the topic from care homes in particular.

What the incident highlighted was the fact that care homes are exempt from the current CO alarm legislation. The list of premises and tenancies that are exempt are:

- A tenancy which the occupier shares accommodation with the landlord or a member of the landlord's family.
- A tenancy which is let on a lease for seven years or more
- Student halls of residence
- Hostels
- Care homes and hospitals

However, if a gas appliance is replaced (excluding cooking appliances), the Building Regulations for the UK stipulate a CO alarm should be installed with the appliance as part of the installation.

#### Take care with wood burners

This photo was a reminder about an incident which we were informed about by a local fire officer. An older man was getting a reputation in the local community for anti-social behaviour and was seen as being drunk due to being red in the face.

Investigations found that he was gradually burning a whole tree trunk on his wood burner, and it was leading to CO being released and he was being poisoned.

Don't do this at home!



# Oil / diesel generators

We have heard (via SGN in Scotland) that there seems to have been a rise in CO incidents linked to oil / diesel generators. As power cuts seem to be becoming more frequent, more generators are being bought for domestic use.



They should not be used inside any building and ideally should be placed some distance away from a property. However, we have heard of instances where generators have been in garages or too close to the house and CO has blown in via vents sometimes setting off the CO alarms in the property.

# Increase in CO related incidents

In 2023-24, engineers from Cadent, the region's gas emergency service, responded to 572 CO-related jobs in Bolton, marking a 26 per cent increase compared to the previous year.

## Staying safe from CO when abroad

Some of you may have read about an incident at the ski resort of Gudauri in Georgia where 12 sleeping workers died in a suspected CO leak from an oil powered generator, following an electricity power cut. They were found in a sleeping area above a restaurant.



Think CO is supporting the Pack Safe campaign set up last summer and mentioned in previous e-newsletters.

There is no universal standard when it comes of CO safety – the laws, regulations and policies differ from one country to another making it difficult to understand what controls are in any destination you visit. CO alarms are the key to helping manage this.
